GREATER PEORIA CONTRACTORS & SUPPLIERS ASSN.

Effective May 1, 2012 thru April 30, 2013

the following Wages and Fringe Benefits shall apply.

Iron Worker Hourly Wage Rate	- \$30.33 per hour
Foreman	- Not less than \$1.90/hr. above scale
General Foreman (15 or more Iron Workers)	- Not less than \$3.00/hr. above scale

Iron Workers Tri-State Welfare Fund	- \$9.39 per hr. worked
Iron Workers Mid-America Pension Fund	- \$6.56 per Reg. hr. worked (9.84 OT)

Central Illinois Construction Industry Fund	- \$.15 per hr. worked
