**TO ALL CONTRACTORS EMPLOYING IRONWORKERS UNDER LOCAL 112 AGREEMENT
WITH GREATER PEORIA CONTRACTORS & SUPPLIERS ASSOCIATION.**

Effective May 1, 2026 thru April 30, 2027

the following wages and fringe benefits shall apply

Iron Worker Hourly Wage Rate	- \$41.05 per hour
Foreman	- Not less than \$2.75/hr. above scale (effective 8/1/25)
General Foreman (15 or more Iron Workers)	- Not less than \$4.00/hr. above scale (effective 8/1/25)

Fringe Benefits

Iron Workers Tri-State Welfare Fund	- \$13.11 per hr. worked
Iron Workers Mid-America Pension Fund	- \$10.00 per Reg. hr. worked (\$15.00 OT)
Iron Workers Mid America SMA Fund	- \$10.75 per Reg. hr. worked (\$16.13 OT)
Combined Central Illinois Construction Industry Fund	- \$.25 per hr. worked
Iron Workers Local 112 Joint Apprentices Fund	- \$.98 per hr. worked
I.M.P.A.C.T. Fund	- \$.33 per hr. worked
TRICON Fund	- \$.06 per hr. worked

Effective May 1, 2026 for all hours not previously remitted prior to this date, employers shall submit employer reports and make ACH payments for all remitted funds to the Iron Workers Mid-America Pension Fund through the Funds I-Remit website per addendum to agreement. Shall apply beginning with May 2026 contributions due by June 15, 2026
